A summary of the report of abuse or neglect and a factual description of the contents of the report: CCFS received a report that a child was transported to a local area hospital by his adult caregiver due to him exhibiting signs of physical distress. Upon medical assessment, the child tested positive for marijuana and was considered in serious condition. The child was admitted to the hospital for ongoing care. There are concerns regarding the child's exposure to marijuana. Law enforcement has been notified regarding the incident.
- D. The date of birth and gender of child: 5/2/2017, male
- E. The date that the child suffered the fatality or near fatality: 10/13/2024
- F. The cause of the fatality or near fatality, if such information has been determined: The cause of the near fatality is under investigation.
