 CCDFS received a report that emergency medical personnel responded to a local residence on a 9-1-1 call regarding a child in physical distress. The child was transported to a local hospital where medical assessment deemed him to be in critical condition and he was admitted to the hospital for further care and treatment. The child has an underlying medical condition, and a concern is noted regarding the overall management of the child's care and condition by his adult caregivers. Law enforcement is investigating the matter.
