- A. Date of the notification to the child welfare agency of the fatality/near fatality of a child:**  
2/10/2024
- B. Location of child at the time of death or near fatality (city/county):**  
Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**  
CCDFS received a report the child was transported to a local hospital pediatric emergency room due to exhibiting signs of physical distress after being dropped off to his adult caregiver by his other adult caregiver and another family member. It was reported that the child had been residing with the first caregiver for a month prior to being dropped off to the second caregiver. Upon noting the child's condition, 9-1-1 was called and law enforcement and emergency medical personnel responded to the residence. Medical assessment of the child determined him to be in critical condition and he was admitted for ongoing care and treatment. There is a concern for non-accidental trauma.

- F. The cause of the fatality or near fatality, if such information has been determined:**  
The cause of the near fatality is under investigation.
- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...**
- (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

CCDFS has the following prior CPS history for this child or member of the child's family or household:

6/6/2017 – A referral was received and was coded "Information Only".

6/7/2017 – A report was received alleging abuse. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was provided with information regarding available community resources and services, and the case closed.

8/16/2020 – A report was received alleging abuse. The report involved the adult caregiver of the child who is the subject of the near fatality report and a non-relative child. Court action was initiated and the child was determined to be in need of protection. The allegation was found substantiated. On 4/26/2021, a second report was received alleging abuse and neglect following the birth of a relevant family member. Court action was initiated and the child was determined to be in need of protection. The allegations were found substantiated. The family was placed under formal supervision, a case plan was put in place, and appropriate referrals and services were provided to the family. On 10/10/2023, the court terminated jurisdiction and the case closed.

7/8/2022 – A referral was received and was coded "Information Only".

8/16/2022 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was provided with brochures and information regarding available community resources and services, and the case closed.

9/14/2023 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated.

**H. Whether the agency which provides child welfare services, in response to the fatality or near fatality...**

CCDFS has opened a case for investigation and family assessment. A companion report and investigation has also been opened with regard to other relevant household members related to the caregivers. CCDFS will, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of the child and/or relevant members of the child's family or the households.
