C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

CCFS received a report that emergency medical personnel responded to a local residence after the child's adult caregiver found the child exhibiting signs of physical distress and becoming unresponsive. The child was transported to a local hospital where medical assessment determined her to be in serious and critical condition. Concerns are noted relating to the home environment. Law enforcement is investigating the matter.

On 4/9/2024, CCFS received notification that the child was pronounced deceased on 4/8/2024.

E. The date that the child suffered the fatality or near fatality:

The cause and manner of death are pending official autopsy findings.

CCFS has the following prior CPS history for this child or member of the child's family or household:

10/14/2022 - A referral was received and was coded "Information Only".

CCFS has the following prior CPS history for the adult caregiver in whose care the child was in at the time of the near fatality:

5/31/2006 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated.

10/17/2006 - A referral was received and was coded "Information Only".

10/25/2007 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated.

5/6/2008 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was provided with referrals based upon assessment, and the case closed.

2/1/2009 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegation was found substantiated. Based upon assessment, the family was provided with information regarding available community resources, and referrals for service. The case closed.

6/26/2009 - A referral was received and was coded "Information Only".

9/7/2009 – A report was received alleging neglect. Court action was initiated, and the adult caregiver's children were determined to be in need of protection. The allegations were found court substantiated. The family was placed under formal supervision and a case plan was put in plan, with appropriate referrals and services being provided based upon assessment. On 3/13/2013, a hearing was held, and an order was entered terminating Wardship. The case closed.

4/2/2024 – A report was received alleging neglect with regard to the child that is the subject of this disclosure and another relevant family member. The case remains open.
