- A. Date of the notification to the child welfare agency of the fatality/near fatality of a child: 7/11/2024
- B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report: CCFS received a report that in early June, the child's adult caregivers called an advice nurse after the child was not eating or sleeping well. The caregivers followed the advice provided, however, did not seek further medical care after that initial call. On 7/11/2024, the family was leaving a local business and one of his adult caregivers noticed the child was showing some signs of possible physical distress. When the family arrived home, his adult caregivers noticed he was not breathing. They called 9-1-1 as they drove to a local hospital. After medical assessment, the child was pronounced deceased. Law enforcement responded to the event. There is a concern that the child's caregivers may not have sought timely medical treatment for the child.
