- **C.** A summary of the report of abuse or neglect and a factual description of the contents of the report: CCFS received a report that law enforcement and emergency medical personnel responded on a 9-1-1 call relating to a child who was found unresponsive the backyard swimming pool of an Air BnB rental. The child had been pulled from the pool and life saving measures were performed on scene. The child was transported to a local area hospital where he was listed in critical condition and admitted for care. There is a concern regarding supervision and the narratives provided surrounding the event.
- D. The date of birth and gender of child: 4/16/2023, Male
- E. The date that the child suffered the fatality or near fatality: 9/10/2024
- **F.** The cause of the fatality or near fatality, if such information has been determined: The cause of the near fatality is under investigation.
