- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

 CCDFS received a report that emergency medical personnel responded to a local residence on a 9-1-1 call concerning an unresponsive child. The child was transported to a local area hospital where medical assessment, determined him to be in critical condition. There is a concern that the child may have ingested a controlled substance, and the overall circumstances surrounding the event. Law enforcement is investigating the matter.

The cause of the near fatality is under investigation.

CCFS has the following prior CPS history for this child or member of the child's family or household:

1/20/2015 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated. Based on assessment, the family was provided with appropriate referrals to available community resources. The case closed.

4/1/2015 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated. Based on assessment, the family was found not to be in need of services and the case closed.

3/15/2018 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. Based on assessment, the family was found not to be in need of services. They were provided for information regarding available community resources, and the case closed.

8/26/2018 – A report was received alleging abuse and neglect. Upon conclusion of the requisite investigation, the allegations were found substantiated. On 9/22/2018, during the course of the open case, a second report was received alleging neglect. Upon conclusion of the requisite investigation in that instance, the allegations were found unsubstantiated. Based on assessment, the family case was transferred for to permanency for voluntary ongoing referrals and services. The case closed.

9/1/2019 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. Based on assessment, the family was provided with appropriate referrals to available community resources.

11/6/2019 – A report was received alleging abuse. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated. The family was not in need of services and referrals and the case closed.

2/19/2020 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family denied being in need of services. They were provided with information regarding available community resources, and the case closed.

6/30/2020 – A report was received alleging neglect. On 7/13/2020, a second report was opened alleging neglect following the birth of another relevant family member. Court action was initiated, and relevant family members were found to be in need of protection. The allegations for both reports were substantiated. The family was placed under formal supervision, case plans put in place, and appropriate referrals and services were provided to the family. On 1/13/2021 a hearing was held, and the court terminated jurisdiction and wardship with a NRS 432B.550(1)9a) Termination Order giving the appropriate parent sole, legal and physical custody of on a relevant family member. A permanency plan was put in place for other relevant family members. On 10/13/2022, the court formally terminated jurisdiction with the permanency goals having been achieved. The case closed.

9/23/2023 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegation was found substantiated. Based on assessment, appropriate referrals and services were provided to the family. The case closed.

2/5/2024 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was provided with information regarding available community resources, and the case closed.
