On 02/06/2025, CCFS received a report that a child was hospitalized late last year for congenital health defects. Upon discharge, the caregiver was medically directed to obtain follow-up care, which the caregiver failed to do. The child was subsequently re-hospitalized in January 2025. The child is currently intubated and in "serious condition."
