- B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report: CCFS received a report that, on 2/14/2025, that emergency medical personnel were dispatched to a local area hotel on a call concerning a teenager who ingested medications. The teenager was transported to a local area hospital where medical evaluation deemed her to be in serious condition. She was admitted to the hospital for continued care and evaluation. The teenager is reported to have mental health related history and there is a concern that the child was left unsupervised, with access to the medications.

The cause of the near fatality is under investigation.
