- B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark
- **C.** A summary of the report of abuse or neglect and a factual description of the contents of the report: CCFS received a report that the child was brought to a local area hospital emergency room by his adult caregiver due to the child being in physical distress. Medical assessment deemed the child to be in serious condition. The child has an underlying medical condition, and a concern is noted with the overall management of the child's condition by his adult caregivers.
- D. The date of birth and gender of child: 12/29/2018, Male
- E. The date that the child suffered the fatality or near fatality: 3/25/2025
- **F.** The cause of the fatality or near fatality, if such information has been determined: The cause of the near fatality is under investigation.
- G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...
  - (1) The frequency of any contact or communication with the child or a member of the child's family or household before the fatality or near fatality and the date on which the last contact or communication occurred before the fatality or near fatality;

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

CCFS has the following prior CPS history for this child or member of the child's family or household:

12/30/2018 – A report was received alleging abuse. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated. Appropriate efforts were made to engage the family in a full assessment process; however, assessment was limited due to the family's lack of cooperation. The family denied needing any services and/or referrals, and the case closed.

6/4/2020 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was provided with appropriate brochures as well as information regarding available community resources and services, and the case closed.

7/27/2020 - A referral was received and was coded "Information Only".

9/16/2020 – A report was received alleging neglect. On 9/25/2020, during the course of the open investigation, a second report was received alleging neglect. Requisite investigations were completed for both reports, with the allegations for the 9/16/2020 report being found unsubstantiated, and the allegations in the 9/25/2020 report being found substantiated. The family was not in need of services and/or referrals, and the case closed.

7/12/2021 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was not in need of services and/or referrals, and the case closed.

2/7/2023 – A report was received alleging neglect. Upon conclusion of the requisite investigation, allegations were found substantiated. The family was not in need of services and/or referrals, and the case closed.
