- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

  CCFS received a report that law enforcement and emergency medical personnel responded to a 9-1-1 call regarding a near drowning incident involving a child. It was reported that the child had been found unresponsive in the hot tub located within an apartment complex community pool area, and where the family was having a planned pool day. The child was pulled from the hot tub, CPR was performed, and the child regained consciousness by the time emergency services arrived. The child was transported to a local area hospital where he was assessed as being in critical condition and admitted for the purpose of observation. There is a concern regarding supervision of the child by his adult caregivers.
