- A. Date of the notification to the child welfare agency of the fatality/near fatality of a child:**

- B. Location of child at the time of death or near fatality (city/county):**  
Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**  
CCFS received a report that law enforcement and emergency medical personnel responded to a local residence on a 9-1-1 call concerning a child who had been found unresponsive in the bathroom of his home by a neighbor. It was reported that the child had been left unattended to supervise younger family members while the adult caregivers went to work. The younger family members later sought help from a neighbor after finding the bathroom door locked. Life saving measures were performed on scene. The child was transported to a local area hospital where he was pronounced deceased. Due to the child having an underlying history of substance abuse and mental health concerns, there are safety and supervision concerns.

- F. The cause of the fatality or near fatality, if such information has been determined:**  
The cause and manner of death are pending official autopsy findings.

CCFS has opened a case for investigation and family assessment. A companion report and investigation has also been opened for other household members connected to the event. CCFS will, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of relevant members of the child's family or household.
