- B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

 CCFS received a report that, on 6/16/2025, the child presented at a local area hospital severely dehydrated and was assessed as being in serious condition. It was reported that the family recently came to Las Vegas from another state and had been outside in the heat. The adult caregivers noticed the child was lethargic and presented with other physical symptoms, and so they transported her to the hospital where the child was admitted for treatment. There are concerns with the length of time the child was exposed to the heat/elements as well as a possible delay in seeking medical attention for the child. There are also concerns regarding inconsistencies in the caregivers' explanation of the timeline of events and their overall history of living arrangements.
