A summary of the report of abuse or neglect and a factual description of the contents of the report: CCFS received a report that, on 6/18/2025, the 17-year-old was riding a motorcycle at a high rate of speed when he crashed into a concrete barrier. Medical personnel responded and he was pronounced deceased on scene. There is a concern that the teenager had access to the motorcycle without a proper legal license. The event is under investigation by law enforcement.

CCFS has the following prior CPS history for this child or member of the child's family or household:

11/1/2012 – A report was received alleging abuse. On 11/26/2012, during the course of the open investigation, a second report was received alleging abuse. Upon conclusion of the requisite investigation for the 11/26/2012 report, the allegation was found unsubstantiated. Based on assessment, appropriate referrals and services were provided to the family. On 1/15/2013, court action was initiated with regard to the 11/1/2012 report. Upon conclusion of the requisite investigation for the 11/2/2012 report, CCFS found the allegations to be substantiated. On 3/13/2013, a hearing was held, and the petition was dismissed by the court, with the condition that the child's caregivers follow the assessment recommendations of a relevant physician and a parenting course be completed. Further concerns were to be addressed in a secondary court in which the family was involved. The case closed.

9/2/2016 - A referral was received and was coded "Information Only".
