- B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report: CCFS received a report that law enforcement and emergency medical personnel responded to a local residence on a 9-1-1 call concerning a child who was found unresponsive by her adult caregivers. Emergency medical personnel initiated CPR and transported the child to a local area hospital. Medical assessment determined the child to be in critical condition and commenced testing to determine the cause of the child's condition. At the time of the report, the child was expected to be transported to another local area hospital for specialized treatment. Concerns were noted that the child's caregivers were unable to provide an explanation for the child's condition. Law enforcement is investigating the matter.

CCFS has the following prior CPS history for this child or member of the child's family or household:

9/12/2024 - A referral was received and was coded "Information Only".

1/26/2025 – A report was received alleging neglect. CCFS responded to the reported address and upon appropriate inquiry, information was received that the family did not reside at the address.
