A summary of the report of abuse or neglect and a factual description of the contents of the report: CCFS received a report that the child's adult caregivers contacted emergency medical personnel after they were concerned that the child was not waking up normally. The child was transported to a local area hospital where she was determined to be in critical condition and tested positive for THC. There is a concern that the child's adult caregivers were unable to provide an explanation as to how the child was exposed to the substance. Law enforcement was informed of the incident.
