- A. Date of the notification to the child welfare agency of the fatality/near fatality of a child:**
9/10/2025
- B. Location of child at the time of death or near fatality (city/county):**
Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**
On 9/10/2025, CCFS received a report that the child was hospitalized out-of-state in serious condition due to complications from an underlying medical condition. The report indicates that the child was taken to a Las Vegas hospital on 9/6/2025, and later transferred to a pediatric intensive care unit out of state. The family had previously resided in another state, where referrals for ongoing care were provided prior to their move. There are concerns that the caregivers have not adequately managed the child's medical needs and may not follow through with the recommended treatment required for her condition.

The cause of the near fatality is under investigation.

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident. This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

CCFS has the following prior CPS history for this child or member of the child's family or household:

3/12/2008 – A report was received alleging abuse. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated, and the case closed.

10/17/2009 – A report was received alleging abuse. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. Based on assessment, the family was not in need of services and/or referrals. The case closed.

7/2/2013 – A report was received alleging abuse. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. Based on assessment, the family was not in need of services and/or referrals. They were provided with information regarding available community resources, and the case closed.

12/2/2014 – A report was received alleging abuse and neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. The family was not in need of services and/or referrals, and the case closed.

8/21/2015 – A referral was received and was coded "Information Only".

8/24/2015 – A referral was received and was coded "Information Only".

2/18/2016 – A referral was received and was coded "Information Only".

2/15/2023 – A report was received alleging neglect. Court action was initiated in the matter. On 4/11/2023, a Disposition Hearing was held and based on paternity results, the Petition was dismissed as to a relevant party. The allegation of neglect relating to this party was found unsubstantiated. The court action remained open as to the other non-relative parties to the Petition.

CCFS has opened a case for investigation and family assessment. A cross report to an out-of-state jurisdiction was also made. CCFS will, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of the child.
