- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

 CCFS received a report that the child was transported to a local hospital by Emergency Medical Services after he reportedly fell onto a floor. Medical assessment determined the child had sustained injuries and was in serious condition. The child was transferred to another local hospital for further specialized treatment. A concern is noted that the adult caregiver's explanation provided as to the mechanism of the injury is not consistent with medical evaluation of the child. Law enforcement is investigating the incident.
