 CCFS received a report that the child's caregivers transported the child to a local hospital due to the child exhibiting signs of physical distress. Upon medical assessment, it was determined that the child had sustained an injury and was in serious and critical condition. There are concerns that the child's primary caregiver was unable to provide an explanation for the child's injury. Law enforcement was contacted regarding the incident.

The cause of the near fatality is under investigation.
