Henderson, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**
CCFS received a report that the child was admitted to a local hospital with injuries and listed in serious condition. It was reported that, on 11/24/2025, the child was taken to a local hospital by two adult caregivers due to concerns with the child's appearance, and he was examined and released. The following day, the caregivers sought care at another hospital when his condition did not improve, and he appeared to be in physical distress. Medical evaluation identified injuries concerning for non-accidental trauma. Law enforcement was notified and is investigating the matter.

The cause of the near fatality is under investigation.

CCFS has the following relevant prior CPS history for this child or member of the child's family or household:

5/27/2015 – A referral was received and was coded "Information Only".

10/22/2015 – A report was received alleging abuse. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. Based on assessment, the family was referred to appropriate services. The case closed.

12/28/2017 – A referral was received and was coded "Information Only".

1/31/2019 – A referral was received and was coded "Information Only".

3/8/2019 – A referral was received and was coded "Information Only".

1/29/2020 – A referral was received and was coded "Information Only".

4/10/2021 – A report was received alleging abuse and neglect. Court action was initiated in the matter with a relevant family member being determined to be in need of protection. The allegations of abuse were found substantiated. During the course of the open case, on 4/23/2021 and 1/27/2022, referrals were received and were coded "Information Only". The family was placed under formal supervision, a case plan was put in place, and appropriate referrals and services were provided to the family. On 3/22/2022, a hearing was held, and the court terminated jurisdiction and wardship. The case closed.

5/8/2023 – A referral was received and was coded "Information Only".

5/10/2024 – A report was received alleging abuse. A secondary referral was also coded "Information Only". Upon conclusion of the requisite investigation, the allegations were found unsubstantiated. Based on assessment, the family was not in need of services and/or referrals. The case closed.

5/28/2024 – A referral was received and was coded "Information Only".

3/25/2025 – A referral was received and was coded "Information Only".
