A. Date of the notification to the child welfare agency of the fatality/near fatality of a child:
11/27/2025

B. Location of child at the time of death or near fatality (city/county):
Las Vegas, Clark

C. A summary of the report of abuse or neglect and a factual description of the contents of the report:
CCFS received a report that law enforcement and emergency medical personnel responded to a local residence on a 9-1-1 call regarding a near drowning incident involving a child. It was reported that the incident occurred while the child was attending a family gathering at the home of relatives. The child was reportedly outside with family members. At some point, the adult caregiver briefly went inside the residence. Upon returning outdoors, the caregiver found the child facing up in the swimming pool.

The child was pulled from the pool, CPR was initiated. The child was quickly revived and transported to a local hospital where medical assessment determined her to be in serious, but stable condition. The child was subsequently transferred to another local hospital for continued care and observation.

At the time of the report, there was insufficient information available to establish possible maltreatment. During the course of investigation, there was a concern noted that the child's caregiver may have failed to exercise reasonable care, supervision, or control in a manner that resulted in physical harm.

F. The cause of the fatality or near fatality, if such information has been determined:
The cause of the near fatality was a result of a near drowning incident.

G. Whether the agency had any contact with the child or a member of the child's family or household before the fatality or near fatality and, if so...

This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

CCFS has no prior CPS history for this child or member of the child's family or household.

CCFS opened an investigation with regard to the near fatality incident. The investigation has been concluded, and based on assessment, the family was provided with an appropriate referral. No further CPS intervention or services has been deemed necessary, and the case has been closed.
