- A. Date of the notification to the child welfare agency of the fatality/near fatality of a child:**
7/17/2025
- B. Location of child at the time of death or near fatality (city/county):**
Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:**
CCFS received a report that law enforcement and emergency medical personnel responded to a local residence on a 9-1-1 call relating to a child near drowning. It was reported that the child's adult caregiver requested another family member start running water in the bathtub while the adult caregiver attended to a second family member in the bedroom. After a few minutes, the first family member ran into the bedroom to tell the adult caregiver that something was wrong. The adult caregiver ran into the bathroom and found the water still running, the bathtub almost full, and the child who is the subject of this disclosure underwater. The adult caregiver pulled the child from the water and called 9-1-1. The child was transported to a local area hospital where medical assessment determined him to be in serious condition. There is a concern relating to supervision by the adult caregiver.

The cause of the near fatality is under investigation.

CCFS has no prior CPS history for this child or member of the child's family or household.
