B. Location of child at the time of death or near fatality (city/county):

Las Vegas, Clark

C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

On 7/28/2025, CCFS received a report that law enforcement and emergency medical personnel responded to a 9-1-1 call relating to a child near drowning that occurred in the family's unfenced backyard pool. It was reported that the child's adult caregiver went to use the bathroom, and when she came out of the bathroom, she did not see the child. The adult caregiver went outside and found the child unresponsive in the pool. The adult caregiver and another adult that also resides in the home, pulled the child out of the pool and 9-1-1 was called. Life saving measures were performed on scene. The child was transported to a local area hospital where medical assessment deemed her to be in critical condition. There is a concern regarding supervision of the child and the totality of circumstances surrounding the event.

On 7/31/2025, notification was received that the child was pronounced deceased.

The cause and manner of death are pending official autopsy findings.
