- A. Date of the notification to the child welfare agency of the fatality/near fatality of a child: 9/30/2025
- B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report: CCFS received a report that the child became unresponsive while in the care of her foster parent. It was reported that the foster parent suspected the child may have ingested prescription medication belonging to another individual residing in the home. The foster parent reported that some medication had spilled onto the floor and was picked up; however, the child later developed symptoms, leading to concern that she may have ingested a missed pill. The foster parent contacted Poison Control and 9-1-1. Emergency medical personnel responded to the home, administered treatment, and transported the child to a local hospital where she was listed in serious/critical condition. Although the incident appears to be an accidental ingestion, at the time of the report, there was concern regarding the foster parent's supervision of the child and/or securing the prescription medication in the home.

rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).

CCFS has the following prior CPS history for this child or member of the child's family or household:

1/4/2024 – A report was received alleging neglect. Court action was initiated, and the child was determined to be in need of protection. The allegations were found substantiated. The family was placed under formal supervision and a case plan put in place. The case remains open for ongoing Permanency services with actions, referrals, and services being provided as deemed appropriate.

CCFS has the following prior CPS history for the foster parent in whose care the child was in at the time of the near fatality incident:

9/6/2019 – A report was received alleging neglect. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated. The family was provided with information regarding available community resources, and the case closed.

12/27/2021 - A referral was received and was coded "Information Only".

7/18/2022 – A referral was received and was coded "Information Only".

11/4/2022 - A referral was received and was coded "Information Only".

9/25/2024 - A referral was received and was coded "Information Only".
