- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

Minor child was seen for a well child exam. During the visit the baby was observed to be malnourished and failure to thrive. Mother took the minor child to the local emergency department. The baby was observed to have no body fat to give an injection. It was recommended for the baby to be seen at the emergency room and if they baby did not go to the emergency room the baby would die. Minor child was then transported to a pediatric medical center where it was discovered through an ultrasound the baby had pyloric stenosis. A pyloromyotomy was performed on the baby August 06, 2023. Since the surgery the baby gained approximately two pounds in two weeks and continues to gain weight.

It was discovered through an ultrasound the baby had pyloric stenosis. A pyloromyotomy was performed on the baby August 06, 2023. Since the surgery the baby gained approximately two pounds in two weeks and continued to gain weight.
