- A. Date of the notification to the child welfare agency of the fatality/near fatality of a child: 08-17-2024
- B. Location of child at the time of death or near fatality (city/county):

Pahrump, Nye County

- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:
 - It was reported he rolled from a bed onto a hard toy. When his mother noticed he was having trouble breathing, she called 911. The child was transported via ambulance to a hospital in Pahrump and then airlifted to Sunrise Hospital where he was transferred to the PICU and was placed on a ventilator. The child was admitted to the PICU at Sunrise Hospital in serious condition diagnosed with Pneumothorax. The attending trauma surgeon stated the injury was not consistent with a fall from a bed and there is concern for non-accidental trauma. However, the attending MD in the PICU as well as the RN stated that the family's report of child's injury being accidental is plausible. Medical staff reported that the child fell from his bed in a "flaccid" manner, meaning he didn't reach out to break his fall. The hospital indicated the hard toy that child fell on was rectangular and 6x8. Because of the lung collapse, the child was intubated.
- **D.** The date of birth and gender of child: 05-03-2022. Male.
- E. The date that the child suffered the fatality or near fatality: 08-17-2024
- F. The cause of the fatality or near fatality, if such information has been determined: Review of records finds one provider indicating the child rolled off the bed, another that he was jumping on the bed when he fell. Pulmonologist found a foreign body in the child's lung, which, per the hospital SW, a nurse said could have been a popcorn kernel.
