A summary of the report of abuse or neglect and a factual description of the contents of the report: Child was reported to have fallen out of the crib, causing facial/ head injuries and a brain bleed. Child has bruising on her arms, legs, buttocks, and large scratches on her back and sides. Law enforcement and EMS responded to the unresponsive child.
- D. The date of birth and gender of child: 11/1/2022
- E. The date that the child suffered the fatality or near fatality: 3/3/2024
- F. The cause of the fatality or near fatality, if such information has been determined: Child abuse

The victim child was discharged from the hospital to the biological mother and does not have contact with the stepmother or father. The agency has filed a petition with the court to have legal oversight of the case.
