Call to dispatch was on 7/23/24 at 8:03am as to a non-breathing infant. Mineral County Sheriff arrived and child taken to a local Hospital, where was pronounced dead at 9:05am.

DCFS opened a report on 6/26/24 for amphetamine exposure in utero of the minor child. An out of home safety plan was established with the mom residing with the maternal grandmother and the baby in Hawthorne, Nevada. The safety provided was vetted and the home was cleared for out of home safety plan. Both physical and telephonic contact was had with the parents, relatives and the minor child. The child was due for his 1-month checkup with his pediatrician on 7/24/24. He was attending his WIC appointments in Hawthorne, and there were no concerns noted. The safety plan had 24/7 supervision of the mother and child and the father also had supervised visi ts in the home. The case is still in the assessment stage, and was in the process of being completed.
