DCFS opened a case on the family in July 2022, at the birth of the deceased child. She had been placed on an in-home safety plan with her parents on 7/26/24 with active safety providers in the home. Monthly visits were up to date with both the worker and the safety providers. The family had lived in Sparks, Nevada, and had just relocated in the last 2 weeks to Fernley, Nevada. The last court hearing was on 6/27/24 for a permanency review.
