- **C.** A summary of the report of abuse or neglect and a factual description of the contents of the report: A report was received on 8/23/2021 with very limited information other than that the 2-month-old child was found on a bed, had vomited with blood coming out of the nose and mouth. She was unresponsive and transported to a local hospital and pronounced deceased.

- E. The date that the child suffered the fatality or near fatality: 08/23/2021
- F. The cause of the fatality or near fatality, if such information has been determined: The cause and manner of death is pending at this time.
