- A. Date of the notification to the child welfare agency of the death of a child:
11/7/2021
- B. Location of child at the time of death or near fatality (city/county):
Reno, NV; Washoe County
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:
A report was received on 11/7/2021 indicating that a 9-month-old child collapsed and stopped breathing in the home. CPR was administered by a family member until emergency personal arrived. The child received life savings measures in the form of Narcan that was provided to him by paramedics that arrived on scene. Child responded well to the Narcan administrations. Child believed to have ingested a narcotic substance. Substance is believed to be pure Fentanyl based on information learned. Exact cause of incident remains unknown. Child was hospitalized for a few days and then released.

2/6/2021; Male
- E. The date that the child suffered the near fatality:
11/7/2021
- F. The cause of the near fatality, if such information has been determined:
Narcotic ingestion
