- A. Date of the notification to the child welfare agency of the near fatality of a child:  
11/12/2021
- B. Location of child at the time of death or near fatality (city/county):  
Reno, NV; Washoe County
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:  
On Wednesday, November 10, 2021, a 10-month-old male was brought the emergency room from the home daycare he had attended that day. He was suffering from severe trauma to his head. The child was diagnosed with a significant skull fracture with brain bleed. He was initially intubated to provide medical care. Intubation was withdrawn on Friday, November 12, 2021, however; he subsequently began suffering seizures and was reintubated that evening to preserve life. He remains under observation in the Pediatric Intensive Care Unit. The explanation provided for the injury is inconsistent with the severity.
- D. The date of birth and gender of child:

Traumatic Head Injury

This limitation is required to preserve the confidentiality of all child abuse and neglect reports and records in order to protect the rights of the child and family as mandated by the Child Abuse Prevention and Treatment Act (CAPTA), as amended (42 U.S.C. 5101 et seq.).
