A summary of the report of abuse or neglect and a factual description of the contents of the report: Child was riding in an ATV with an older sibling and the ATV rolled over and pinned the youth under the ATV. Medical personal arrived and assessed that youth needed to be taken by care flight for emergency medical treatment. Youth was diagnosed with two fractures in his lower back and a small laceration/nick to his liver. He was admitted to the PICU at a local hospital and released the following day.
