Reno, NV; Washoe County
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:
On 11/24/2022 a report was received after a 2-year-old child was found face down, unresponsive, and cold to the touch in the family home. Child was transported to a local hospital for attempted life-saving measures, which were not successful; initial impressions at hospital are respiratory failure. Injuries were ruled out at autopsy. Child had a history of febrile seizures. Cause of death is pending.
