- A. Date of the notification to the child welfare agency of the fatality of a child: Near Fatality: 8/24/2022 Fatality: 8/31/2022
- B. Location of child at the time of death or near fatality (city/county): Reno, NV; Washoe County
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report: A report was received on 8/24/2022 indicating that an 18-month-old male was found unresponsive in a crib at the family home. Life saving measure were performed by the family, emergency medical personal and hospital personnel. He was pronounced deceased but then eye movement and some breath sounds were noted, and he was intubated at that time. He is currently hospitalized on life support.

Update: 8/31/2022 Further toxicology testing was performed, and child was found to be positive at time of admission for Fentanyl. Medical records confirm no Fentanyl was given for treatment and ingestion occurred in the mother's home. Life support services withdrawn on 8/31/2022 and child was pronounced deceased.
