## INFORMATION FOR RELEASE

- A. Date of the notification to the child welfare agency of the fatality/near fatality of a child: Notification of a near fatality on 12/19/2023.
- B. Location of child at the time of death or near fatality (city/county): Reno, NV; Washoe County
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report: Near fatality, ingestion of methamphetamine and fentanyl: Call for respiratory distress and child unresponsive. REMSA gave baby Narcan without response, performed combination of CPR and back thrusts and manually intubated her for transport to Renown. Renown gave Narcan again and there was some response but not prolonged and a Narcan drip was administered. Baby is now off the Narcan drip but is still on oxygen and will remain in hospital until breathing better without oxygen. Baby tested positive for methamphetamine and fentanyl.

- E. The date that the child suffered the fatality or near fatality: 12/19/2023
