A summary of the report of abuse or neglect and a factual description of the contents of the report: On August 17, 2023, a female teen was brought to a local hospital after she reportedly ingested Benadryl in a suicide attempt. She is in serious/critical condition but stable. She was reportedly homeless (living on the streets) for one week prior to LEA locating and releasing her to her parents where she then later attempted suicide. She will be discharged to a mental health facility.
- D. The date of birth and gender of child: 04/13/2009: Female
- E. The date that the child suffered the fatality or near fatality: 08/17/2023
- F. The cause of the fatality or near fatality, if such information has been determined: Benadryl ingestion
