- B. Location of child at the time of death or near fatality (city/county): Reno; Washoe County
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report: Youth was swimming with her siblings at a local casino pool. There was adult supervision, but the child went under water and did not surface. It is unknown how long the youth was under water but emergency life saving measures were successful and the youth was transferred to a local hospital where she was intubated and admitted.

The case was open to DCFS at the time the report was received. There was no evidence or information that suspected that child abuse or neglect occurred and that this was an accidental drowning and was not assigned for an investigation. LEA was called to the scene and concluded that there was no parental fault and determined this was an accident.

DCFS was consulted and they would follow up with the family due to the open case.
