 The juvenile and her stepfather were at an unmanned shooting range in Storey County to target shoot/practice. It is believed that the juvenile was loading a firearm when she sustained a gunshot wound to the chest. She was transported by the stepfather to the hospital where she was pronounced deceased.

- E. The date that the child suffered the fatality or near fatality: 10/7/2023
