- B. Location of child at the time of death or near fatality (city/county): Reno, NV; Washoe County
- C. A summary of the report of abuse or neglect and a factual description of the contents of the report: On May 11, 2023, a report was received indicating that a three-year-old male child was transported to a local emergency room after he was found to be choking on a foreign object and having difficulty breathing while at a daycare facility. CPR was attempted by school staff and emergency medical personnel without success. He was placed on life support but expired several hours later.
- D. The date of birth and gender of child: 6/20/2019; Male
- E. The date that the child suffered the fatality or near fatality: 5/11/2023
- F. The cause of the fatality or near fatality, if such information has been determined: Pending autopsy

#### **No Prior History**
