**WCHSA had legal and physical custody of the child at time of death. The last child contact was conducted on June 25, 2024, frequency of contact was at 1 or more in-person contacts per month. Family was being served with permanency services, plan of reunification.**

**5/18/23 – Inadequate supervision, physical risk – substantiated**  
**2/7/2019 – Abandonment – Unsubstantiated**  
**8/15/2018 – Medical neglect – unsubstantiated – voluntary services**  
**10/12/16 – physical risk – unsubstantiated – voluntary services**  
**09/16/14 physical risk - substantiated**

The information contained in this section is limited to contact(s) with the child who is the subject of this disclosure or a member of that child's family or household that is related to the fatality or near fatality incident.
