WCHSA received a report of suspicion on 5/29/25 and opened an investigation. On 6/4/25 healthcare professionals deemed the incident a near fatality, however the child was presenting with medical complications throughout the month of March and healthcare professionals were referring to the child's medical issues in totality, therefore an exact date of when the near fatality occurred is unclear.

WCHSA implemented safety planning during the course of the investigation and is now providing services and assistance to the family.
