 - Carson Region (Carson City, Douglas, and Storey counties)
 - No reviews this quarter
 - Clark County
 - o 18 natural deaths, 13 accidents, 6 homicides, 4 suicides, and eight undetermined deaths.
 - Within those 13 accidents, there were four motor vehicle deaths, 4 drownings, and four asphyxia deaths due to unsafe sleep.
 - O Within those homicides, four were due to firearms.
 - No recommendations

- 12. For Possible Action: Acknowledgment of receipt and response to the regional CDR Team 2025 Quarter 2 recommendations presented during agenda item 11. Denise Tyre, Co-Chair
 - O Recommendation related to proper use of car seats. Caregivers improperly used a car seat by having a small child placed and left in that child car seat for an extended period of time instead of having the child placed in a proper sleeping arrangement. As a result of that, the child became entangled in the car seat.
 - Region is working with some of our community partners in trying to develop or have information disseminated throughout the Community regarding the proper use. The Family Resource Center and another service provider out here that assist with providing families with car seats and installing them correctly and through the course of that there is education. However, if you don't go to them, they will not be able to send that information out.
 - Safe KIDS Has offered to share resources about this recommendation regarding car seats to Mr. Cason, who also shared that he is open to receiving more resources for his community through and that they have a family Resource Center, which would be a good place to start.
 - O April Stahl: The committee needs to decide if this is if the recommendation is going to be a statewide effort that the Executive Committee is going to take on, or if that recommendation can be sent back to the region that made the recommendation to handle locally.
 - O Vicky Ives. For the record, I think it might be helpful to get with the Office of Traffic Safety and get a better idea of the efforts they're making. There are components in the statewide Safe sleep program that specifically mentioned car seats in relation to not leaving children in them during transfer, that doesn't match perfectly with this, but there are some touch points there.
 - EC voted to Acknowledging the receipt of the recommendation and that agencies will support the Pahrump office with additional services to be handled at the local level.

And they were amazing, wonderful human beings and I think that everyone should remember humanity, remember their humanity and there are people that are affected deeply by these deaths. My family and I will never be the same because of one of these deaths. Thank you
