OUTPATIENT

How many outpatient providers are registered with NV Medicaid to provide in home therapeutic services? How many have billed Nevada Medicaid in the last 12 months?

Is there a way to track number/capacity of Medicaid therapists who have some level of culturally affirming training/credentialed?

INTENSIVE IN HOME

How many mobile crisis teams are currently in place by region in Nevada? 14 active teams in South currently – can go up to 16

What is the current capacity of Mobile Crisis Intensive Step-Down program by region in Nevada?

How many intensive outpatient "beds" are there by region in Nevada?
