The 2026 recommendations from Nevada's Children's Justice Act (CJA) Task Force and Citizen Review Panel (CRP) reflect a strategic shift toward a more holistic, equitable, and prevention-focused child welfare system. Building on prior progress in forensic interviewing, multidisciplinary team (MDT) collaboration, and access to Child Advocacy Centers (CACs), the Task Force now emphasizes the importance of upstream prevention, procedural fairness, and culturally responsive oversight. These recommendations aim to align Nevada with national best practices, reduce long-term system burdens, and improve outcomes for children and families. (See emailed attachment)

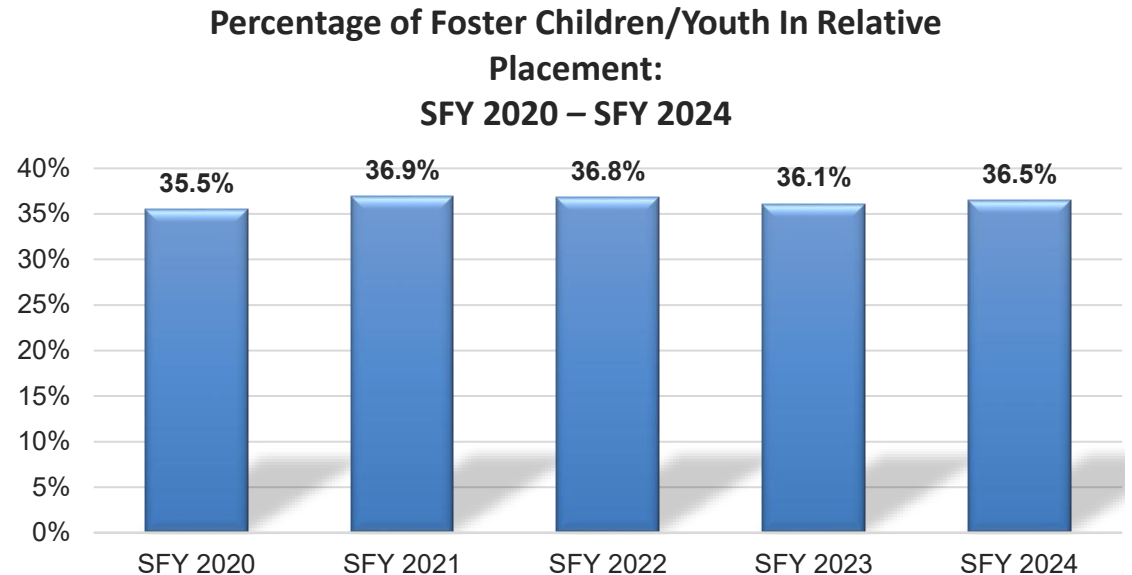
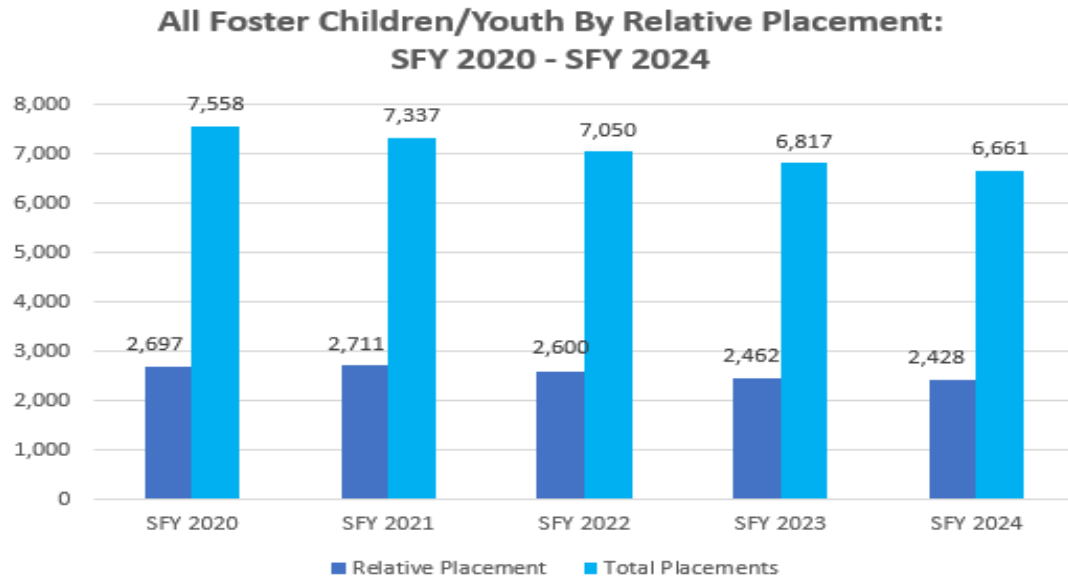
- Item 9 is measured by preserving the child in cares connections. Nevada experienced an increase in Item 9 strength ratings since the completion of its last PIP.
