<sup>5</sup> As of 2012, there was a new methodology used to calculate the caseworker visits measures. Because the new methodology limits data comparisons with prior years, caseworker visits data from 2010 and 2011 are not included in this table. All states have the option of using an approved sampling procedure for the caseworker visits reporting requirement.
