Subject: Victims of Domestic Violence or Sexual Violence- Marriage License (ML) Funding
Recommendations

The Notice of Funding Opportunity was released on February 28, 2023, for a total funding amount of \$5,900,000 for Federal Fiscal Year 2023.

All applications were reviewed and evaluated in accordance with both the ML eligibility criteria pursuant to Nevada Revised Statutes (NRS) 217.400 to 217.460. Total funding requested was \$6,819,641.10.

Pursuant to NRS 217.450 subsection (3), DCFS shall award grants to not more than two applicants to provide services for domestic violence and two applicants to provide services for victims of sexual violence in counties whose population is 100,000 or more. DCFS received three applications to provide services for victims of domestic violence in both Clark and Washoe County and was unable to fund one of the applications in each county.

The Evaluation Committee determined 14 applications should be funded and provided the following funding recommendations:
