C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

On 3/11/2021, CCDFS received a report that the 5-year-old child was in critical condition at a local hospital after sustaining injuries while in the care of a babysitter. It was reported that the babysitter contacted the parents and reported the child was in physical distress and the parents rushed to the home. The child was then transported to the hospital where he was unresponsive upon arrival. The babysitter was taken into law enforcement custody.

On 3/12/2021, CCDFS received notice that the child had coded on 3/11/2021 and was pronounced deceased.
