- A. Date of the notification to the child welfare agency about the fatality or near fatality of a child: 11/10/2021
- B. Location of child at the time of death or near fatality (city/county): Las Vegas, Clark
- **C.** A summary of the report of abuse or neglect and a factual description of the contents of the report: On 11/8/2021, CCDFS received a report that the child was seen by his pediatrician and based upon medical assessment, the pediatrician instructed the child's adult caregiver to immediately take the child to a nearby local hospital for further medical treatment. The hospital was contacted to advise of the caregiver and child's impending arrival. Several follow-up calls were made to the hospital, however, the caregiver and child failed to arrive.

On 11/10/2021, another hospital advised that the child was admitted to Pediatric Intensive Care Unit and assessed as being in serious condition.

- **D.** The date of birth and gender of child: 10/12/2021, Male
- E. The date that the child suffered the fatality or near fatality: 11/10/2021
- **F.** The cause of the fatality or near fatality, if such information has been determined: The cause of the near fatality is under investigation.

CCDFS received one prior CPS report for this child or member of the child's family or household. On 10/12/2021, a report was received alleging abuse and neglect. Upon conclusion of the requisite investigation, the allegations were found unsubstantiated.

CCDFS has opened a case for investigation and family assessment. CCDFS will, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of the child.
