- C. A summary of the report of abuse or neglect and a factual description of the contents of the report:

 CCDFS received a report that the child's adult caregiver contacted 9-1-1 due to the child exhibiting signs of physical distress. Emergency medical personnel responded to the residence and transported the child to a local hospital. Based upon medical evaluation, the child was determined to be in serious condition and arrangements to transport him to another local hospital for specialized care was being arranged. There is a concern that no information or explanation was provided by his caregiver that would account for the child's condition.

CCDFS has no prior CPS history for the adult caregivers in whose care the child was in at the time of the near fatality.

CCDFS has the following prior CPS history for this child:

6/20/2020 – A report was received alleging abuse. Upon conclusion of the requisite investigation, the allegation was found unsubstantiated. Based upon assessment appropriate referrals and services were provided to the family. The family had support from other family members and the child was deemed safe at case closure.

9/27/2021 – A report was received alleging neglect. Court action was initiated, and the child was determined to be in need of protection. The Court ordered the child to be placed in the home of an appropriate out-of-home caregiver. The allegations were found substantiated. A case plan was put in place, with services and referrals being provided based upon assessment. The case remains open.

CCDFS has opened a case for investigation with regard to the child who is the subject of this disclosure. A companion investigation has also been opened with regard to other relevant household members related to the caregivers. Family assessment will remain ongoing and CCDFS will, as deemed appropriate, provide child welfare services, make referrals for child welfare services, and/or take action concerning the welfare and safety of the child and/or relevant members of the child's family or household.
